Identity and Address of Responsible Party

Personal Data Processed by AMAFORE

AMAFORE processes personal contact and identification data collected via the website for the purpose of inviting you to participate in a specific event, providing you with information about the Retirement Savings System solely for educational purposes, or proffering advice on the use of tools to calculate an estimated pension.

Furthermore, to fulfil the primary and fundamental purposes outlined in this Privacy Notice, AMAFORE will not collect or process sensitive personal information.

Primary Purposes

AMAFORE may process your personal data to fulfil one or more of the following primary and fundamental purposes:

- Inviting you to participate in a virtual or in-person event organized by AMAFORE.
- Pre-registering you for an event organized by AMAFORE.
- Reminding you of the date, time and topic of the event for which you registered.
- Sending you any necessary information for your entry and/or arrival at the event for which you expressed your willingness to register.
- Inviting you to participate in similar events to the one you registered for.
- Responding to any queries you send to AMAFORE, which, in accordance with the aforementioned association's corporate purpose, it has the means to answer.
- Inviting you to use its educational and informational tools regarding retirement savings to calculate an estimated pension.

It is our duty to inform you that you cannot object to AMAFORE ceasing any processing of your data for the primary and fundamental purposes mentioned above, as said processing is necessary to ensure your registration and participation in events organized by AMAFORE, as well as to respond to any queries you may send.

Secondary Purposes

Additionally, AMAFORE will use your personal information for the following purposes, which are not necessary for your registration for events organized by the Association but which allow us to provide you with a better level of service:

- Sending you information relating to the Retirement Savings System solely for educational purposes, or providing advice on the use of tools to calculate an estimated pension.

If you do not wish for your personal data to be processed for one or all of the secondary purposes, you may notify us at this time by sending an email to contacto@amafore.org, indicating in the subject line "PERSONAL DATA PROCESSING" and specifying in the body of the email your full name, which data you do not want to be processed, and for which secondary purpose(s). We would appreciate it if you could attach a copy of your official identification to this email.

Opting out of your personal data being used for secondary purposes will not be deemed to grounds for denying your registration for other events organized by AMAFORE or refraining from responding to any query that, within AMAFORE's scope of knowledge and publicly available information, it is capable of answering.

Transfers

To fulfil the primary purposes described above or to meet any other requirements mandated by current legislation or the authorities, AMAFORE will transfer the necessary personal data to the following organizations and for the following purposes:

- Recipient of personal data: Company or companies that use registration forms and registration platforms for virtual or in-person events.
 - Purpose: To manage registration requests.
 - Consent: Not necessary.
- Recipient of personal data: Authorities.
 - Purpose: As specified.
 - Consent: Not necessary.

Limitations on Data Use and/or Disclosure

You may limit the use and/or disclosure of your personal data at any time by sending an email to contacto@amafore.org, indicating in the subject line "PERSONAL DATA PROCESSING" and specifying in the body of the email your full name and which data you wish to limit the use and/or disclosure of. We would appreciate it if you could attach a copy of your official identification to this email.

If your request is approved, we will proceed to add you to AMAFORE's General Exclusion List.
